Dear District 150 Parents,

South Holland School District is currently putting together a comprehensive Roadmap to Reopening Guide for the 2020-21 school year, which will be based on guidance from the <u>Illinois</u> <u>State Board of Education</u> and the Illinois Department of Public Health. In addition, the district is reviewing feedback from a survey administered to all parents in June, and district leaders are meeting with staff, parents and community representatives to receive feedback. South Holland School District will present its Roadmap to Reopening to the Board of Education on/or before July 21<sup>st</sup> and send it out to parents on/or before July 27th.

We understand some families may not feel comfortable sending their children to school this fall. All will have the opportunity to indicate if they would like to opt out of in person learning and choose to remain home for all Distance Learning. Any family that chooses to enroll in the all Distance Learning option will do so for the first semester. Families will be allowed to change to in-person learning at the end of the first semester. Families will have until Friday, July 17<sup>th</sup> to complete the short survey below to indicate whether they will be sending their child to in-person learning or plan to opt out of in person learning for the all Distant Learning for the first semester.

It is important that parents complete this survey for each of their children to help with the planning and scheduling of instructional activities. If you do not complete the survey it will be assumed that your child will be assigned to the hybrid model (a combination of in-person and distant learning) We thank you for your time and feedback.
