Parents, Guardians and Staff,

South Holland School District is committed to providing a safe, secure and healthy learning environment for all students and staff. We believe that students learn best when they are in the school setting. Further, the socialization aspects of school are critical in a student's life. We believe that we must protect our children from bringing the virus home to their families who may be more susceptible. We believe that protecting our children protects the community. Therefore, South Holland SD150 will be starting the school year with a remote learning model for the first quarter. Staff will be working in their assigned classrooms utilizing the tools and resources to provide a quality teaching and learning experience for our students. We will evaluate our plan after six (6) weeks and determine if and when we will move into a hybrid model or fully restored model.

Efforts have been made to align with CDC guidelines, the Illinois Department of Health and the Illinois Department of Education.

Surveys in regard to the reopening of schools were provided to parents, students and staff to help in preparing reopening guidelines.

The following will occur for the 2020-21 school year and/or until updated guidance is provided. *More specific building guidelines will be provided separately.* All parents are required to acknowledge they have read and received the guidelines by signing appropriate forms. Please note that the well-being of our students and staff is of the highest priority. We met with various stakeholders during the month of July and solicited information from several surveys to gather information to support our decision-making. According to the results of our July parent survey; 42.04% of families indicated that they would send their children to an in-person hybrid model starting in the fall and 57.96 % of families indicated that they would opt out of in-person for a remote learning model. We have 704 families total with 333 families who responded to the survey.

This plan is subject to change and may become less restrictive as conditions improve or more restrictive, if warranted. The COVID-19 pandemic has forced us as leaders to make some of the most difficult decisions we have ever faced. We will always err on the side of caution and in the best interest of students and staff. It is our sincerest hope that your child attends South Holland SD150 this coming fall. We have missed them greatly!
